RESOLUTION TO SUBSCRIBE TO AN ON-LINE EMPLOYEE SCHEDULING AND WORKFORCE MANAGEMENT SYSTEM FOR HIGHLAND PARK POLICE AND FIRE DEPARTMENTS

WHEREAS, scheduling of Highland Park police and fire personnel must be in compliance with all legal and contractual requirements, including, but not limited to: seniority, overtime, employee availability, vacations, etc.; and

WHEREAS, the current scheduling system used by the Police and Fire Departments is time-consuming and inaccurate resulting in additional costs to the City; and

WHEREAS, Aladtec provides employee scheduling and workforce management solution software for police and fire employees that will address the needs of Highland Park; and

WHEREAS, the implementation of this technology will assist management in providing accurate employee scheduling and workforce management resulting in reduced costs to the City through the reduction of overtime, the minimization of supervision, reduction in errors and correct scheduling of employees; and

NOW, THEREFORE, BE IT RESOLVED by the City that it allow the Highland Park Police Department to purchase an Aladtec subscription for the amount of \$7,200 annually. Yeas (4), Nays (0), Absent (1).

RESOLUTION TO ISSUE CONTRACT FOR STREET SWEEPING

WHEREAS, the City of Highland Park has 7 miles of major roadways, 46 miles of local roadways, 28 miles of alleyways and two municipal parking lots; and

WHEREAS, the appearance of the City is vital to the health, safety and well-being of the residents and the public at large; and

WHEREAS, the appearance of the City will enhance future economic development prospects and the financial recovery of the City of Highland Park; and

WHEREAS, the City received one bid as a result of an RFQ from Progressive Sweeping Contractors, Inc. (see attached); and

WHEREAS, Progressive Sweeping Contractors, Inc. 5202 Enterprise Blvd., Suite B, Toledo, OH 43612-3809 is the recommended contractor; and

NOW, THEREFORE, BE IT RESOLVED by the City of Highland Park that DPW and the City Engineering Department be allowed to issue a contract to Progressive Sweeping Contractors, Inc. in an amount not to exceed \$241,149 for year 1, \$244,767 for year 2 and \$248,445 for year 3 for street sweeping services to paid in full with Act 51 monies. WHEREAS, the City of Highland Park City Water Department held public hearings at the regular City Council Meetings on May 20th and June 3rd, regarding the 2020 SRF Project Plan Application; and

hearing and documented; and

BE IT RESOLVED, after documentation of all comments received from citizens, the Water Department Director is authorized to take all necessary actions to give this resolution effect this 3rd day of June 2019. Yeas (4), Nays (0), Absent (1).
