WHEREAS Lisa Stolarski has not acquired a two-million-dollar bond since March 18, 2024; and

WHEREAS Lisa Stolarski has not been bonded by the County of Wayne since March 18, 2024; and

WHEREAS the City of highland Park Charter, in Section 4-10, Subsection 9 states that a City office becomes vacant when there is a failure to file the bond required for the office as required by law, the Charter or City Ordinance; and

WHEREAS the Charging and Fueling Infrastructure Discretionary Grant Program (cfi Program) established under the Infrastructure Investment and Jobs Act ("Bipartisan Infrastructure Law" of "BIL") was developed by the U.S. Department of Transportation. The CFI Program investments are meant to make modern and sustainable infrastructure accessible to all drivers of electric, hydrogen, propane, and natural gas vehicles. The BIL provides \$2.5 billion over five years for this program to strategically deploy electric vehicles in urban and rural communities in publicly accessible locations, including downtown areas and local neighborhoods, particularly in underserved and disadvantages communities; and

WHEREAS the City of Highland Park as a community is confirmed to meet eligibility requirements; and

WHEREAS community benefits may include job training and local economic opportunities for workers, reduced greenhouse gas emissions, improved local air quality, and enhanced economic viability for the City of Highland Park; and

WHEREAS the City of Highland Park was invited to jointly pursue a portion of the \$10,900,000 in federal funds along with eight other Southeast Michigan municipalities for a total project cost estimated at \$13,000,000 under the condition that Frances Energy has agreed to match \$2,700,000 (20%); and

WHEREAS the City of Highland Park will not be required to provide any match of the awarded grant amount; and

WHEREAS the grant application value for the City of Highland Park is estimated to between \$700,000 and \$1,000,000 and it will cover procurement and installation of EV charging stations that can be described as (8) Level 2 AC type 16.64kW Single Port Dispensers (J1772), & two (2) DC fast Charging type 200kW Dual-Port Dispensers (NACS+CCS); and

NOW, THEREFORE, BE IT RESOLVED, that the Highland Park City Council approves the submittal by the City's administration, of the CFI Grant Application requesting a total award value for Highland Park of between \$700,000 and \$1,000,000 to the U.S. Department of Transportation by September 11, 2024 and if the CFI Grant Application is awarded, this Council shall take action to approve its receipt. WHEREAS on May 6, 2024, the City Engineering Department and Community and Economic Development Department confirmed the vacation of 274 W. Grand Street Exhibit B (attached)

WHEREAS it was discovered upon further review by the State of Michigan of the legal description for the vacated parts of the streets and alleyways that certain parts of the description resulted in ambiguity or omitted parts of the streets and alleyways intended to be vacated. This resolution is being submitted as a corrective version as provided by the Means Highland Park, LLC surveyor of record;

WHEREAS, in furtherance of the Resolution by Highland Park City council on April4, 2022, it is confirmed that all the street and alleyways depicted on the attached "Exhibit C" and within the boundaries of said lands as described in the attached "exhibit D" are vacated. This letter will serve as our final approval and confirmation of the vacation of streets and alleyway for Means Highland Park, LLC Hamilton Corridor Project;
