An ordinance to amend the Highland Park Administrative Code, by adding Chapter ___ to prohibit all forms of recreational marihuana establishments within the City of Highland Park.

State Law reference: Michigan Regulation and Taxation of Marihuana Act, MCL 333.27951 et seq.

NOW THEREFORE, The City of Highland Park ordains:

Section 1. Title

This ordinance shall be known and cited as the City of Highland Park Marihuana Establishments Ordinance.

Section 2. Marihuana Establishments

As permitted in section 6.1 of the Michigan Regulation and Taxation of Marijuana Act, the City hereby completely prohibits any marihuana establishments as defined in the Act from locating and operating within the boundaries of the City.

WHEREAS, MI-HOPE seeks to provide energy-efficiency assistance to eligible households having income equal to or less than 300% of the federal poverty level as outlined in United States Department of Treasury Guidance; and

WHEREAS, MI -HOPE assisted activities are limited to: roofs; storm doors/exterior doors; windows; modification/efficiency or replacement of heating (furnaces or boilers), cooling (full only), ventilation systems, and water heater upgrades (including on demand retrofitting); and up- to-date exterior security lighting; and

WHEREAS, the City has already applied for a funding in Round 3 and wishes to apply for Round 4; and

WHEREAS, the City of Highland Park is currently in litigation regarding the total volume of sewerage being transported for treatment to the Great Lakes Water Authority (GLWA); and

WHEREAS, the City of Highland Park objective is to gradually reduce the amount of sewerage being transported for treatment to the GLWA; and

WHEREAS, this grant program will provide infrastructure and planning grants that directly address the impacts and vulnerabilities presented by severe weather events, with a focus on projects that address flooding, coastline erosion, urban heat, and storm water management; and

WHEREAS, to meet the eligible activities, the Water and Engineering Departments will develop feasibility studies or engineering plans for nature-based and green infrastructure projects that address climate and storm resiliency on city owned right-of-way or parcels; and

WHEREAS, to meet some of the eligible activities, the Water and Engineering Departments, in coordination with the Department of Public Works and Parks and Recreation, will potentially use this for additional tree planting projects and/or separating stormwater and sewer lines, focusing in areas of repeated basement flooding; and

WHEREAS, to meet some of the eligible activities, the Water and Engineering Departments will consider possible relocation and protection of critical infrastructure (e.g., roads, sewer, water line) using nature based and climate resilient principles; and

WHEREAS, the Water and Engineering Departments shall utilize grant funds to update the current stormwater management standards within the current Engineering Standards Manual and produce a feasibility study that will result in a reduction with non-point source stormwater pollution throughout the city; and

BE IT RESOLVED, the City of Highland Park City Council approves the acceptance of the 2023 State High Water Infrastructure Grant Program for a total of \$1,500,000 to the State of Michigan Department of Environment, Great Lakes, and Energy (EGLE). Yeas (5), Nays (0), Absent (0).

WHEREAS, it is necessary for the City of Highland Park Water Department to address water main improvements identified in the 2016 MDEQ (EGLE) Violations Notice and Administrative Consent Order; and

WHEREAS, the City of Highland Park previously received a Significant Deficiency Violation Notice from EGLE on April 11, 2016 regarding the existing water infrastructure; and

WHEREAS, the City of Highland Park previously received a Lead and Copper Monitoring – Action Level (AL) Exceedance letter from EGLE on July 12, 2019 regarding the community water supply’s 90th percentile value exceeding the action level for lead during the most recent round of lead and copper monitoring between June and September 2019; and

WHEREAS, as a result of exceeding the lead Action Level (AL) the City of Highland Park is required under the administrative rules promulgated under the Michigan Safe Drinking Water Act, 1976 PA 399, as amended (Act 399) to meet additional requirements including water quality parameter monitoring, source water monitoring, corrosion control treatment, and public education, as well as being mandated to replace a higher percentage of lead service lines; and

WHEREAS, the City Council has reviewed and approved the FY2020-24 DWRP Project Plan Application as submitted to EGLE, of which the 2023 project is portion of the scope; and

WHEREAS, it is the intent of the Water Department Director that when funds are awarded by the State of Michigan Department of Treasury to begin construction in October of 2023; and

BE IT RESOLVED, the City of Highland Park City Council approves the acceptance of the 2023 AMERICAN RESCUE PLAN – STATE REVOLVING FUND GRANT PROGRAM for a total of \$10,105,000 from the State of Michigan Department of Environment, Great Lakes, and Energy (EGLE). Yeas (5), Nays (0), Absent (0).
