RESOLUTION TO APPROVE OPTION TO PURCHASE AND SALE OF COMMERCIAL LOT AND BUILDING LOCATED AT 12024 WOODWARD AVENUE TO JAKM HOLDING, LLC (OPTIONEE) SHOULD OPTION TO PURCHASE BE TIMELY EXERCISED BY OPTIONEE

WHEREAS, the City of Highland Park (the "City") owns surplus real property in its inventory which real property is currently neither habitable, operable nor producing meaningful property tax revenue for the benefit of the City and its citizens; and

WHEREAS, it is the stated desire of the City to reduce its inventory of surplus real property and sell such parcels to individuals and/or entities which intend to develop and improve those parcels so that they may become habitable, operative, productive, and producing property tax income for the benefit of the City and its residents all in accordance with the City's Ordinances; and

WHEREAS, the City owns the vacant building and lot located at 12024 Woodward Avenue, the legal description of which is set forth on the attached Exhibit "A" (the "Property") which is specifically incorporated by reference into this Resolution; and

WHEREAS, the Optionee (whose principal is Lawrence Johnson) proposes to renovate the building located upon the Property and create a breakfast cafe to seat up to 80 persons inside the building and up to 80 persons outside; and

WHEREAS, the development of the Property into a breakfast cafe is beneficial to the City and its residents; and

WHEREAS, the City Attorney prepared an Option to Purchase, to which there are attached as exhibits, a Purchase Agreement, and a Development Agreement for the sale of the Property to Optionee should Optionee timely exercise its option to purchase the Property; and

WHEREAS, the Development Agreement would be executed by the City and the Optionee on the date which Optionee closes on its purchase of the Property; and

WHEREAS, the option price of \$2,500.00 (10% of the purchase price, and which is characterized as a Performance Bond under Ordinance Number 208.07) is payable by Optionee to the City upon its execution of the Option to Purchase and is non-refundable but applicable to Optionee's purchase of the Property under the Purchase Agreement should the Option to Purchase be timely exercised by Optionee.

NOW, THEREFORE, BE IT RESOLVED, that the City Council approves: (1) the granting of the Option to Purchase to Optionee; (2) the execution of the Option to Purchase by a member of the City's

administration; (3) sale of the Property to the Optionee for a sale price of \$25,000 under the Purchase Agreement should Optionee timely exercise its option to purchase the Property; (4) the execution of the Purchase Agreement by a member of the City's administration once it signed by Optionee and (4) the execution of the Development Agreement by a member of the City's administration on the date Optionee closes on the purchase of the Property. RESOLUTION TO APPROVE THE HIGHLAND PARK FIRE DEPARTMENT TO APPLY FOR THE FEMA ASSISTANCE TO FIREFIGHTERS GRANT FOR A NEW FIRE TRUCK

WHEREAS, The City of Highland Park Fire Department is a unit of the certified local government in which the City of Highland Park can apply for annual grants; and

WHEREAS, grants are available for certified local governments (CLG's) to provide funding for priority projects identified in FEMA's 'Notice of Funding Opportunity; and

WHEREAS, the Fire Department, through internal review, has determined the need for a new fire engine, due to current in-service engines needing many costly repairs; and

WHEREAS, the current in-service engines are older than what the National Fire Protection Association (NFPA) recommends fire departments to have; and

WHEREAS, a new fire engine would better protect the citizens of the City of Highland Park, their

property, and the firefighters working for the Fire Department; and

WHEREAS, the FEMA Assistance to Firefighters Grant request amount is for \$500,000, with 5% being paid by the City of Highland Park; and

WHEREAS, the application is due on Friday, March 8th by 5pm; and

WHEREAS, the City of Highland Park Mayor, administrative departments, engineering, and building department are supportive of the grant; and

NOW, THEREFORE, BE IT RESOLVED, that the City Council approves the Highland Park Fire Department to apply for FEMA's Assistance to Firefighters Grant for a new fire engine to replace one of the existing fire engines. (5), Nays (0), Absent (0).

NOW, THEREFORE, BE IT FURTHER RESOLVED, that, if there are no individuals that received votes in the last preceding election for City Treasurer that are eligible to hold office, the Highland Park City Council directs City staff to post the position of City Treasurer so that qualified candidates may be considered for placement in the position by the Highland Park City Council and pending a Special Election to elect a permanent replacement. Vacancy posted on February 23, 2024. Submission deadline March 4, 2024. Special Meeting to hold interviews March 11, 2024. Appointment March 18, 2024. Yeas (5), Nays (0), Absent (0).
